IV. EXAMINER

Examiner's Name: Eugénie CHAUMONT

The Examiner certifies that she has acted independently and impartially and to the best of her knowledge has no known conflict in serving as the Examiner in this administrative proceeding.

V. RELIEF SOUGHT

The Complainant requests that the domain name be suspended for the balance of the registration period.

The Respondent has not submitted a Response.

VI. STANDARD OF REVIEW

Clear and convincing evidence.

VII. DISCUSSIONS AND FINDINGS

A. Complainant:

The Complainant, Veolia Environnement, states it is the holding company of Veolia group, 170 years old group, which represents today a total of €44.692 million in revenue in 2024.

Complainant also indicates that he is the holder of the trademarks VEOLIA and the logo drop and affirms that both trademarks are well-known.

After the detection of the disputed domain name, Complainant sent a cease-and-desist letter to Respondent and to the registrar by e-mail on the basis of its trademark rights. Complainant did not receive any reply.

According to Complainant's trademark information, he is the owner of the trademarks :

- international trademark VEOLIA number 814678 in classes 1, 6, 9, 11, 17, 19, 32, 35, 36, 37, 39, 40, 41 and 42;
- international trademark VEOLIA number 919580 in classes 9, 11, 16, 35, 36, 37, 38, 39, 40, 41 and 42;
- international semi-figurative trademark logo drop number 878086 in classes 09, 11, 16, 32, 35, 36, 37, 38, 39, 40, 41, 42, 44.

The Complainant furnished a copy of the CDL and of the trademarks but no proof of use at all, not even a printout of its website.

According to the Complainant, the domain <veolia.click> is at least confusingly similar with the Complainant's trademarks "VEOLIA".

The domain name is used to direct towards the Registrar waiting page.

B. Respondent:

The Respondent did not submit a Response to the Complaint.

C. Procedural findings:

Having reviewed the communications records, the Examiner finds that MFSD has discharged its responsibility under the URS Procedure paragraphs 3 and 4 and URS Rules paragraph 4.

In accordance with URS Rules Paragraph 9(d), in absence of a Response, the language of the Determination shall be English.

D. Findings of fact:

The Examiner was appointed on 9 September 2025. On 10 September 2025, the Complainant contacted MFSD with the following information:

We have leaned this morning that this domain name was registered by a staff member of Veolia Environnement.

Is it possible to put an end to the procedure?



MFSD informed the Examiner of this update on 12 September 2025. The Examiner reviewed the file and indicated on 16 September 2025 that she was prepared to terminate the Proceedings under Article 16 of the URS Rules unless a Party raised justifiable grounds for objection within 8 days. MFSD informed the Parties accordingly on 16 September 2025. The Complainant indicated on 16 September 2025 that it had no comments with regard to the Examiner's intention to terminate the Proceedings.

On 30 September 2025, the Examiner noted that the 8 day period was over. The Examiner raised a point regarding the contact details of the Respondent. MFSD responded on 3 October 2025 to confirm that MFSD gave notice of the Complaint to all available contact details of the Respondent as confirmed by the Registry Operator.

On 6 October 2025, the Examiner confirmed that she agrees to the termination of the Proceedings under Article 16(b) of the URS Rules. The Proceedings were then ultimately terminated and was confirmed to the Parties.
